The EU-funded project [INCLAVI](#) (INCLusive AViation), develops an accredited online learning platform, targeting staff in airlines and in the aviation industry in general, to train them to better serve Persons with Disabilities (PwD) and others with specific accessibility requirements. INCLAVI drives change in air transport accessibility through respect, dignity, and inclusivity.

Project Status

The INCLAVI project is at a crucial stage, as we have started developing a comprehensive curriculum consisting of 40 accessibility-focused modules. Designed in collaboration with university and industry partners, these modules will be available free of charge to aviation and tourism professionals wishing to enhance their accessibility knowledge.

The curriculum will be hosted on an easy-to-use Learning Management System (LMS), supported by a mobile app, offering self-paced, fully online training. We are currently in the demo phase, featuring six modules, available here: [INCLAVI Curriculum](#).

Demonstration of the INCLAVI Training Curriculum

The training curriculum is designed to support the educational and skills development of industry professionals and students in higher education and vocational training. Following the INCLAVI pedagogical pathway, 40 training modules will be offered in a flexible, modular framework covering key aspects of service design for Passengers with Reduced Mobility (PRMs) in the aviation sector. Modules will be delivered both on a mobile App and through a Web platform with basic, intermediate, and advanced learning paths for front-line staff, managers, and students.

The consortium members attended two events during January 2025 with the objective to disseminate the project and showcase the training curriculum:

[Matka Travel Fair](#) in Helsinki, Finland (January 16-19) – The INCLAVI Consortium took part in the biggest travel and tourism fair in Nordic Europe. During the event, the Consortium, together with the event hosts Suomen Matkailualan Liitto (Association of Finnish Travel Industry), organized a panel discussion on accessible tourism. Representatives from the International Air Transport Association (IATA), European Network for Accessible Tourism (ENAT), Istanbul Grand Airport (IGA), Haaga-Helia University of Applied Sciences, and Palmuasema (a Finnish accessibility expert) outlined the latest developments and future trends in accessibility, all the while highlighting the urgency of advancing on the travel and tourism industries' preparedness ahead of the upcoming EU Accessibility Act enforcement.
