The EU-funded project <u>INCLAVI</u> (INCLusive AVIation), develops an accredited online training curriculum, targeting staff in airlines and in the aviation industry in general, to train them to better serve Persons with Disabilities (PwD) and others with specific accessibility requirements. INCLAVI drives change in air transport accessibility through respect, dignity, and inclusivity.

Project Status

The INCLAVI project has developed 40 accessibility-focused modules designed in collaboration with university and industry partners. These modules are already available free of charge to aviation and tourism professionals wishing to enhance their accessibility knowledge.

The curriculum is hosted on an easy-to-use Learning Management System (LMS), supported by a mobile app, offering self-paced, fully online training. We are currently in the demo phase, featuring 14 modules, available here: <u>INCLAVI Curriculum</u>.

Based on the ongoing work across WP2 (Current State Analysis), WP3 (Curriculum Development and Piloting), WP4 (Recognition and Certification), and WP5 (Quality Assurance and Evaluation), the INCLAVI project is now ready to demonstrate an example of the learning materials developed by the consortium.
